1. e-APPLICATION FOR AMENDED BE

Amendment on over-declared of income or under-claimed of tax reliefs can be done via e-Application for Amended BE. Amendment is subject to the following conditions:

- 1. Submission via e-Filing (e-BE),
- 2. Submission is within stipulated period (not late submission),
- 3. e-Application for amended BE (for that particular YA) is a one time submission.
- 4. Supporting document must be uploaded as per format required in the column provided.

e-Application for Amended BE can be access via MyTax at https://mytax.hasil.gov.my/> e-Filing from April 1st 2023.

4. TAX REFUND OR TAX ARREARS?

Congratulations to our unsung heroes for submitting Return Forms for the Year of Assessment 2022. According to HASiL's client charter, any excess of tax payment will be refunded as follows:

- e-Filing submission: 30 working days from e-BE submission;
 or
- Manual submission: 90 working days from Return Form submission.

On the other hand, if there is tax payable, it is due on or before the deadline of Return Form submission :

- 1. e-Filing Submission 15th May 2023
- 2. Manual Submission- 30th April 2023

Payment mode is via Mytax https://mytax.hasil.gov.my > ByrHASiL

Instalment payment upon application is available using the following methods:

- 1. **Self- Instalment Application** whereby taxpayer submit his instalment schedule with supporting document; or
- 2. CP38 deduction for taxpayers with employment income.
