1. YOU MAY ELECT NOT TO FURNISH A RETURN IF THERE IS A MONTHLY TAX DEDUCTION ?

You are considered to have fulfilled your responsibilities to the country despite choosing not to submit the Return Form to the IRBM. This method is called MTD as Final Tax and is subjected to Section 77C, Income Tax Act 1967. Easy, isn't it?

How to opt for MTD ?
Just ensure that you:

- Has income only in respect of gains or profits from an employment;
- Is employed by the same employer in that year of assessment;
- MTD is deducted according to Income Tax Rules;
- Tax is not borne by the employer; and
- Not opted for joint/combined assessment with the spouse.

If you do not meet the above criteria or wish to claim additional deduction or rebate, then the Return Form must be submitted



2. ADDITIONAL TAX RELIEFS FOR YEAR OF ASSESSMENT (YA) 2020

Newly Introduced Tax Reliefs

- Medical expenses for fertility treatment for self or spouse up to RM6,000.

Additional deduction for the purchase of personal computer, smartphone or tablet for self, spouse or child and not for business use **made within the period of 1st June 2020 to 31st December 2020 up to RM2,500.**

- Payment for accommodation at premises registered with the Commissioner of Tourism and entrance fee to a tourist attraction for individuals **incurred on or after 1st March 2020** up to RM1,000.

4. 31 MARCH 2021 : THE DEADLINE FOR SUBMITTING FORM E (REMUNERATION FOR THE YEAR 2020)

Employers are highly encouraged to use e-Filing via MyTax at <https://mytax.hasil.gov.my/> for the submission of Form E.

5. CP500 PAYMENT FOR EVERY TWO MONTHS

The first payment starts in March 2021 for six instalments until Jan 2022. The deadline for the first payment is on 30 March 2021.
